On June 8, 1957, Ray was born to Deanna and Stanley Tibbetts.

By 1958, the Tibbetts had five children under the age of ten: Suzanne, Rick, Archie, Ray and Willie.

Life at home was traumatic and chaotic.

certainly does not promise very much in the way of further probationary or social treatment in the community and GIS was recommended". She married Mr. Tibbetts on 6/25/43 in Cincinnati and from this union had five children. This has been a rather stormy marriage, due mostly to Mr. Tibbett's desertion. Mr. Tibbetts is one of six children born to Cornelius and Ada Tibbetts. He was formerly married and had one child. Constance. age 14 from this marriage. Both parents were abusive, alcoholics, and struggled to provide basic care for their children.

With their parents absent from the home, Suzanne was forced to care for the younger boys even though she was just a child herself.

In July 1959, Children's Services removed all of the Tibbetts children from their parents' home and placed them in the foster care system.





## Living at the Merrimans

Children's Services first placed the children with the Merrimans.

Children's Services noted the unsatisfactory conditions at the Merrimans as early as October 1960.

and Mrs. Merriman's nome being approved as a boarding nome of the egent for the Merriman children only, I have not been satisfied with this arrangement and have therefore supervised this home closely. There are too many conflicting and disturbing factors to make this a good placement for the children. The situation demands continual vigilance in order to formulate careful future plans for the best interest and welfare of the Tibbetts children.

The State failed to take any corrective action or remove the children.

In addition to fostering the five Tibbetts children, the Merrimans also had four biological children living in the home at the same time.

Despite continued documentation of abuse in the Merriman's home, Children's Services still failed to take any action to protect or remove the children. In May 1961, Ms. Tibbetts brought Suzanne and Rick home under agency supervision.

Claiming lack of financial resources, Ms. Tibbetts left the three younger boys with the Merrimans.

She doesn't offer the children any security. disciplining the children. The woman needs help. She simply doesn't want the responsibility of these children. She is very narcissistic and full of self-pity. an unstable and unpredictable woman,

When Suzanne and Rick were taken back home, the three youngest boys - Archie, Ray and Willie were forced to stay at the Merrimans.

Suzanne and Rick told their mother about the abuse at the Merrimans, but again, Children's Services took no action to remove the boys.

the Merrimans, saying Suzanne is now telling her the many cruelties they all received; couldn't watch TV, were beaten if they spiled their pants, were tied in bed, didn't get to eat after school - had to go outside or to bed, beat Suzanne's ear - if she didn't cry, beat her harder. Suzanne says she couldn't talk before because she would be beaten if anything got back to the Merrimans. Ricky verifies these statements adding the Merrimans had eggs or french toast for breakfast, but the Tibbetts always had oatmeal. After Willie was severely burned, the State finally removed the three boys from the Merrimans in November 1961.

## Living at the Oswalds

Children Services then placed Ray and Willie with the Oswalds where they lived with at least five other foster children and the Oswald's five biological children.

Archie briefly returned to his mother's home but was quickly separated from the family and placed in various other foster homes.



Wille and Raymond were quite restless, being unable to sleep at night. This kept the foster parents awake. Wille, during this period of time, wet the bed constantly while Raymond rocked himself to sleep. Children's Services attempted to reconnect the boys with their parents for years with no success.

The Tibbetts have not visited the boys, Mrs. Oswald says, since 12-66. This worker has been unable to contact Mr. Tibbetts, so it is suggested that the new worker continue to try to find these parents, as visits are important to these boys. There has been no recent word from them, nor are we aware of their present address or circumstances. It would be strongly advisable for the new worker to attempt to locate them, as their visits have some real meaning to the boys.

## Life after the Oswalds:

After ten years in the Oswald's home, the State removed Ray and Willie.

After leaving the Oswalds, the boys cycled through orphanages, group homes, and the juvenile detention center.

By the age of 14, Ray had already begun drinking and abusing drugs.

#### Suzanne:

At 14, Suzanne ran away from home.

She lived on the streets and spent time in juvenile detention.

She got married at the age of 15 and had 2 children.

Suzanne left her abusive husband after 13 years of marriage.

She has been married 4 times.

Suzanne still struggles with mental and physical illnesses, but she finally has some stability in her life.



#### Rick:

Rick left home at an early age.

He briefly served in the military, but was discharged.

Rick struggled with drug abuse and spent time in and out of jails.

Rick never found a stable home or long-term employment.

He lives alone in a single-room transient motel in St. Petersburg.

He plays music on the street and in bars to make ends meet.



#### Archie:

Archie remained separated from the family as a teen.

He struggled with addiction and became involved in the criminal justice system.

He spent much of his adult life in and out of prison.

When he was not in prison, he was transient and lived alone.

At the age of 44, Archie committed suicide.



### George:

As a teen, George began abusing alcohol and struggling with addiction.

George has wrestled with the demons from his abusive childhood his entire life.

He served 10 years in prison.

George struggles with mental health issues but is currently stable with counseling and a medication regime.
